Warrick County School Corporation Waiver and Release of Liability

In consideration of being permitted to access and use the facilities at the Warrick County School Corporation for the event/activity described below, I agree to the following:

1. I waive and release Warrick County School Corporation, its agents, servants, employees, insurers, successors, and assigns from any and all claims, demands, causes of action, damages or suits at law or equity of any kind, including, but not limited to, claims for personal injury, property damage, medical expenses, loss of income or services, on account of or in any way related to or growing out of my presence or involvement at the School Corporation facility and in the activity described below.
2. This waiver and release is intended to and does release Warrick County School Corporation from any and all liability for damages or injuries in any way related to or growing out of my negligence, the negligence of third parties, and the Warrick County School Corporation's negligence.
3. I further covenant and agree not to institute any claims or legal action against Warrick County School Corporation concerning the matters released by this Waiver. Should I, anyone on my behalf, or claimants who assert a right to sue Warrick County School Corporation because of their relationship with me, make a claim against Warrick County School Corporation in contravention of this Waiver, I will protect, defend and indemnify (reimburse) Warrick County School Corporation for its expenses, including attorney's fees.
4. I agree that Warrick County School Corporation is not responsible for lost, stolen, or damaged valuables or property.
5. I acknowledge that there are rules and regulations governing the use of the facility. I agree to inform myself of those rules, regulations, and amendments thereto and that I will fully comply with them.
6. I have read this Waiver and understand that by signing this, I have consented to be bound by its terms, including the waiver/release of any legal right to sue Warrick County School Corporation for injuries, losses, and costs that the School Corporation incurs because a claim or legal action is made in violation of this Agreement. This waiver is binding on me and my successors, heirs, and assigns. I agree any violation of this Waiver and its terms and conditions, as determined by an administrator of the Warrick County School Corporation, may result in loss of my permission to use the facility.
7. I am at least eighteen (18) years of age and sign this Waiver and Release freely, voluntarily, and competently.
