GENERAL EXPECTATIONS

The Warrick County School Corporation agrees to implement the following statutory requirements as deemed necessary by federal law.

THE WARRICK COUNTY SCHOOL CORPORATION WILL:

Put into operation programs, activities, and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities, and procedures will be planned and operated with meaningful consultation with parents of participating children.

Work with its schools to ensure that the required school-level parental involvement policies meet the requirements of section 1118(b) of the ESEA, and each include, as a component, a school-parent compact consistent with section 1118(d) of the ESEA.

Incorporate this district-wide parental involvement policy into its LEA (Local Education Agency) plan developed under section 1112 of the ESEA.

Carry out the Title I, Part A parental involvement requirements, and to the extent practicable, provide full opportunities for the participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children, including providing information and school reports required under section 1111 of the ESEA in an understandable and uniform format and, including alternative formats upon request, and, to the extent practicable, in a language parents understand.

THE WARRICK COUNTY SCHOOL CORPORATION WILL:

Involve the parents of children served in Title I, Part A schools in decisions about how the one (1) percent of Title I, Part A funds reserved for parental involvement is spent, and will ensure that not less than ninety-five (95) percent of the one (1) percent reserved goes directly to the schools.

IMPLEMENTATION OF REQUIRED COMPONENTS

1. The Warrick County School Corporation (WCSC) will take the following actions to involve parents in the joint development of its district-wide parental involvement plan under section 1112 of the ESEA:

At the first *Parent Advisory Board* meeting of the year the Parental Involvement Policy will be discussed with parents. At following meetings throughout the year, suggestions and concerns from parents will be addressed.

Committee members will be asked to evaluate the Parental Involvement Policy.

2. The WCSC will hold at least one Parental Advisory Board meeting per year (or more as deemed necessary) to review school status and federal guidelines to meet requirements under section 1116 of the ESEA.
3. The WCSC will provide necessary coordination, technical assistance, and other support to assist Title I, Part A schools in planning and implementing effective parental involvement activities to improve student academic achievement and school performance.

1. The WCSC will coordinate and integrate parental involvement strategies.
2. The WCSC will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A schools. e. Limited English Program (LEP) Coordinators will, upon request, provide language appropriate materials.

The LEP Coordinators will, upon request, provide translators for Parent/Teacher Conferences, etc.

f. Parents have the right to request a conference(s)/meeting(s) with the student’s teacher to discuss the individual child’s achievement.

DISCRETIONARY COMPONENTS

The Warrick County School Corporation recognizes that a child’s education is the responsibility shared by each school and the family agrees that to effectively educate all students, the school and parents must work as knowledgeable partners.

We define parent and family involvement as an ongoing process that assists parents and families to meet their basic obligation as their child’s first educator, promotes clear two-way dialogue between home and school, and supports parents as leaders and decision makers at all levels concerning the education of their children.

To support these efforts, a Title I Parent Advisory Board has been established and meets at least annually. The purpose of this board is to assist the Title I staff in the development, implementation, and evaluation of parental programs that will meet the needs of all parents.
