Finance Committee Decision

Athletic teams no longer need to work a concession to be considered for a donation but teams that do work will be a top priority when money is allotted. Allotments will be tabled until March. Stephanie DuPont will send out request forms to all middle and high school coaches in January. Any request can be submitted. The financial committee will decide how much money is able to be allotted per request. Many coach requests will go before Mr. Brown, the athletic director, before they come to the Booster Club. The Booster Club will now reward all season requests/ allotments in March at the end of the concession season. Before the next financial committee meeting, Stephanie DuPont will send out team requests to the committee so that they can review it before the meeting. There are usually no more than five members chosen for the financial committee. A motion was made by Elizabeth Silke and seconded by Melissa Pemberton to approve this decision.

Winter Sports Forms

Senior Ads will be due Nov. 20. Stephanie DuPont will get those forms out soon. Senior parents will be contacted to place an ad for their senior. Melissa Pemberton will create the Sports book next year.

Recruitment of New Members

Member recruitment for next year has already begun. Stephanie DuPont would like to have a table at middle school games. She may also look at making a “newsletter”. We will need to replace most of the current officers.
